- Proof of address is (photocopy of current hydro /cable /gas/ internet/ landline telephone bill or Residential Tenancy Agreement with a current household bill (cell phone bills not accepted) is required for applicants.
- If applicant is not able to provide proof of address MSD staff are entitled to verify proof of address for applicants. By providing original letter on MSD letter head, signed for verification.
- LAC cards are not transferable and must be presented at each use.
- LAC cards are issued for up to 12 months.
- \$2.00 replacement fee for lost or stolen cards.
- Applicants must re-apply with MSD to verify continuing financial need and residency.
